Purpose

- To provide Medicare Advantage Organizations (MAOs) and other entities that are currently submitting encounter data with operational guidance on testing and submitting production data to the Encounter Data System (EDS).
- To provide new 2013 MAOs and other entities with resources and operational guidance related to certification and submission of encounter data to the EDS.
- To provide Medicare Advantage Organizations (MAOs) and other entities information on EDS policy.

MAOs and Other Entities

- CMS requires the following types of organizations to submit encounter data:
 - Medicare Advantage (MA) Plans
 - Medicare Advantage-Prescription Drug (MA-PD) Plans
 - Health Maintenance Organizations (HMOs)
 - Special Needs Plans (SNPs)
 - Local Preferred Provider Organizations (PPOs)
 - Regional PPOs
 - Employer Group Health Plans
 - Programs of All-Inclusive Care for the Elderly (PACE) Plans
 - Cost Plans (1876 Cost HMOs/CMPs and 1833 HCPPs)
 - Medical Savings Account (MSA) Plans
 - Private Fee-for-Service (PFFS) Plans
 - Religious Fraternal Benefit (RFB) Plans
 - Provider Sponsored Organizations (PSOs)





Encounter Submissions for Capitated Services

- Analysis of encounter data submissions shows a less than expected submission volume of capitated services to the EDPS.
- MAOs and other entities in a capitated provider agreement are required to submit encounters for all capitated services.

 Data Elements (MDE) document for submission guidance,

EDPS Edits

- Effective March 29, 2013, when the gender submitted on the encounter is different from the gender stored in the Common Medicare Environment (CME) tables, MAOs and other entities will receive the following reject edit:
 - Edit 02120 Beneficiary Gender Mismatch



EDS Operational Highlights



Highlight #1 ZIP Code +4 Default Value

- Effective May 3, 2013, MAOs and other entities must populate '9998' as the +4 default value.
- MAO and other entities may begin to populate the '9998' default +4 value sooner than May 3, 2013, but no later in order to avoid receiving errors.



Highlight #2 EDS File Limitations

- At this time, CMS is not changing file size restrictions.
- CMS recommends that ISA/IEA transaction sets not exceed 5,000 encounters, as the EDS processes smaller files more efficiently than larger files.
- This submission recommendation is applicable for all connectivity methods:
 - FTP
 - NDM
 - Gentran/TIBCO



Highlight #2 EDS File Limitations (cont'd)

- CMS recommends that FTP submitters upload no more than one (1) file per five (5)-minute interval.
- MAOs and other entities should refrain from submitting multiple files within the same transmission.
- NDM and Gentran/TIBCO users may submit a maximum of 255 files per day.

Highlight #4 PACE Submission

- The PACE certification deadline was February 28, 2013 for MAOs and other entities effective prior to 2013.
- PACE organizations are required to begin submitting 2013 DOS production data once they have achieved end-to-end certification. Production data includes:
 - Institutional, Professional, and DME encounters for services for which claims are generated or for which encounter data is otherwise available.
- PACE organizations are not required to submit encounters for services provided to PACE participants by PACE staff.
- CMS will continue discussions regarding submission of PACE services provided to PACE participants by PACE staff.

MAOs and other entities may populate Loop 2430
 DTP*573 with the MAO or other entity's receipt date
 minus one (1) day as the default primary payer
 adjudication date *only* in the instance that the primary
 payer adjudication date is not available.



Minimum Data Elements (MDE)



Note: MAOs and other entities must continue to reference the TR3, CEM Edits Spreadsheets, and EDS Companion Guides for submission guidance.



Minimum Data Elements (cont'd.)

- The MDE include the minimum list of file header and trailer level data elements.
 - This list is not inclusive of all situational loops, segments, and data elements.
 - MAOs and other entities must refer to the 837-I and 837-P TR3 and CEM edits spreadsheet to determine the correct usage of situational fields.
- The 837 contains fields that are specific to the electronic submission of a file. If these data elements are not populated, the file will not pass translator and CEM level edits.

Special Considerations – Ambulance

Professional Submission

If the true ambulance pick-up and drop-off locations are available from the provider, MAOs and other entities must include at least minimum data elements and the following:

Loop 2310E – Ambulance Pick-Up Location

Loop 2310F – Ambulance Drop-Off Location

Special Considerations – Ambulance (cont'd.)

Professional Submission

If the true ambulance pick-up and drop-off locations are **not** available from the provider, MAOs and other entities must include minimum data elements and the following using the <u>Billing Provider's</u> address:

Loop 2300 – Claim Information

PWK01 = 'AM' (Ambulance Certification)

PWK02 = 'AA' (Available on Request at Provider Site)

Loop 2310E – Ambulance Pick-Up Location

Loop 2310F – Ambulance Drop-Off Location

Special Considerations – Ambulance (cont'd.)

Institutional Submission

MAOs and other entities must include the minimum data elements, as well as the ambulance pick-up ZIP code, according to the following guidance:

Loop 2300 – Claim Information

HI01-1 = 'BE' (Value Qualifier)

HI01-2 = 'AO' (Value Code)

HI01-5 = ZIP Code + 4, when available (Value Code Amount)

Loop 2400 – Service Line Information

SV201 – Service Line Revenue Code

If the true ambulance pick-up ZIP code is **not** available, MAOs and other entities should use the Billing Provider's ZIP code. If the Rendering Provider is different than the Billing Provider, MAOs and other entities should use the Rendering Provider's ZIP code.
