User Group Process

Payment Process

CMS has transitioned to the new email address, analyst@askriskadjustment.com, to receive payment related questions from plans. Because of the new process, the response rate has increased from 38% resolved from the previous email address to 60% resolved in February and 73% resolved in March from the new transitioned email address.

Plans may experience longer response times for more complex questions submitted that require additional research.

What does the risk score mean on the Model Output Report (MOR)?

CMS does not report the risk score on the MOR. The MOR displays the HCCs used to calculate the risk score. The report lists beneficiaries' Health Insurance Claim Number (HICN), Name and Date of Birth. The MOR will report the HCCs, interactions and hierarchy. In the case of hierarchies, CMS reports the most severe HCC. For example, if a beneficiary triggered an HCC17 and HCC19 only the HCC17, CMS will display the HCC17 on the MOR since it is the most severe in the hierarchy.

- National Sampling CMS notified plans in the national sample in December 2008. The medical review submission deadline was February 27, 2009.
 Following the close of the medical review submission deadline, CMS sent tracking reports to plans in the national sample. The tracking reports lists items received and status of coversheets. CMS has not received responses from contracts indicating discrepancies with tracking report. If plans identify discrepancies, report the discrepancy to CMS.
