- Valid ICD-9 diagnosis codes
 - The new ICD-9 diagnoses are effective for Final 2009 Payments (DOS 1/1/08 – 12/31/08).

Access the codes at http://www.cms.hhs.gov/MedicareAdvtgSpecR ateStats/06 Risk adjustment.asp#TopOf Page.

- Valid codes are ICD-9 diagnoses that CMS accepts as valid but may not be included in the CMS-HCC Model and are not counted in the risk score.
- Relevant codes are ICD-9 diagnoses that CMS accepts as valid, are included in the CMS HCC Model, and are counted in the risk score.





The following updated errors will be used for the new ICD-9 diagnosis codes:

450 Error Code will be issued when a submitted diagnosis code is not valid.

451 Error Code will be issued when the diagnosis service date is more than 92 days after the diagnosis end date, and if the diagnosis start date is after the service through date.

453 Error Code will be issued when the sex of the Beneficiary is not the same as the sex of a gender specific diagnosis.

<u>501 Error Code</u> will be issued when the submitted diagnosis is a valid code but is not included in the CMS-HCC model.

 - a) Represent a violation of 42 CFR 422.301; and
 - b) Will be considered for payment adjustment.
