Payment Process

Planned Payment Report (PPR)

The Automated Plan Payment System (APPS) produces the PPR or Payment Letter and itemizes final monthly payments to Managed Care Organizations (MCO) as part of the month-end process.

Budget Neutrality Factor

The Budget Neutrality Factor is calculated as the difference between payments under 100 percent of the risk adjustment method (i.e., under the CMS-HCC Model) versus payment under 100 percent of the demographic only method. Data Validation

Calendar Year (CY) 2007

The sampling phase for CY 2007 is in progress and includes sampling for a Pilot as well as the Standard Data Validation between June and August 2008.

CY 2006

The Quality Assurance stage for the CY 2006 Data Validation is in progress. CMS anticipates the results in early fall 2008.

CY 2005

CY 2005 Data Validation is in the Appeals Process stage and the projected date for completion is July 2008.

Operations Update

Common Error

The Risk Adjustment Processing System (RAPS) will reject diagnosis clusters with error code 411 if the date of discharge is after the date of death. Plans may not change the date of discharge on an inpatient claim. However, plans can change the date of discharge for risk adjustment submission, if the hospital refuses to change the discharge date (through date) to the date of death.
