#### Proposed Rule for Encounter Data

The proposed Inpatient Prospective Payment System rule regarding collecting encounter data clarifies CMS' authority to collect data and expand the types of plans to collect data from such organizations as religious fraternal benefit organizations and Medicare Savings Accounts.

## **Data Validation**

## Calendar Year (CY) 2007

The development of the CY 2007 Data Validation sample is currently in progress. CMS anticipates contacting the selected MA organizations beginning in late May or early to mid-June.

#### CY 2006

The Initial Validation Contractor (IVC) and Second Validation Contractor (SVC) have completed their medical record reviews for the CY 2006 Data Validation sample and are currently in the analysis stage. CMS anticipates reporting the findings to MA organizations in early to mid-summer.

#### CY 2005

CMS has begun reviewing CY 2005 Data Validation appeals. Please be aware that the review of appeals may take longer than expected due to the larger than expected volume of appeals.
