

# Non-Payment for VAD Under Medicare Part A

• In order to process replacement accessory and supply claims for Ventricular Assist Devices (VADs) not paid under Medicare Part A, CMS has added the following codes to the Healthcare Common Procedure Coding System (HCPCS) code set:

Code	Code Description
Q0507	Miscellaneous Supply Or Accessory For Use With An External VAD
Q0509	Miscellaneous Supply Or Accessory For Use With Any Implanted VAD For Which Payment Was Not Made Under Medicare Part A

These codes are effective for services on or after 04/01/2013.

# Non-Payment for VAD Under Medicare Part A

• The following code was added to the HCPCS code set to replace miscellaneous VAD accessory and supply code Q0505:


Code	Code Description
Q0508	Miscellaneous Supply or Accessory For Use With An Implanted Ventricular Assist Device (Replaces code Q0505 – discontinued 03/31/2013)

- Q0508 clarifies that the miscellaneous supplies and accessories billed are for use with implanted VADs.
- Effective for DOS on or after 04/01/2013, the EDS will reject encounters submitted using HCPCS code Q0505.

- The EDFES will reject submission of Q0505 with Professional CEM Edit





- Effective for DOS on or after 07/01/2014, the following Institutional error codes will generate a 'Reject' disposition on MAO-002 Reports.
- Dates prior to 06/30/2014 will generate an 'Informational' disposition.

• The EDPS will reject an encounter and generate Error Code 22390 - HIPPS Code Required for SNF/HH when:

OR

- TOB = 18X or 21X
- Claim From DOS is equal or greater than 07/01/2014
- Revenue Code = 0022
- A SNF HIPPS Code is not present

# Error Code 22395 - HIPPS Code Conflicts with Revenue Code

 The EDPS will reject an encounter and generate Error Code 22395 - HIPPS Code Conflicts with Revenue Code when:

OR

- TOB = 18X or 21X
- Claim From DOS is equal or greater than 07/01/2014
- Revenue Code = 0022
- SNF HIPPS Code is not valid

# Error Code 22400 - HP Qualifier Must Exist for HIPPS Code

 The EDPS will reject an encounter and generate Error Code 22400 - HP Qualifier Must Exist for HIPPS Code when:

OR

- TOB = 18X or 21X
- Claim From DOS is equal or greater than 07/01/2014
- Revenue Code = 0022
- HIPPS qualifier 'HP' is not present



# Error Code 20515 – DX Code V053 Must Be Aligned with HCPCS

 The EDPS will generate informational Error Code 20515 – DX Code V05.3 Must Be Aligned with HCPCS when:





### **EDS Operational Highlights**

# Highlight #1 - Error Code 21950 -Line Level DOS Required

- The editing logic for error code 21950 has been enhanced to validate the header level Date of Service (DOS) 'From' and 'To' date span, when the DOS is more than one day.
- This edit will also meet the requirements for line level DOS that were previously validated with the following edits:
  - 22205 Service Line Missing DOS
  - 20500 Invalid DOS for Rev Code Billed
  - 17100 DOS Required for HH Encounter
- These edits will generate only for specific conditions.
- Comprehensive logic and error resolution strategies for these edits will be included in a future Institutional EDS Companion Guide.

## Highlight #2 - Error Code 02240 -Beneficiary Not Enrolled In MAO For DOS



#### **Decreasing Error Code 02240**

To assist with prevention and reconciliation of this error, **prior** to submission of encounter data, MAOs and other entities should verify that beneficiaries are enrolled in the MAO during DOS on the encounter.

### Highlight #3 - New HCPCS Codes


- CMS has added nine (9) 'G' codes (G0396, G0397, and G0442 – G0447) to the list of acceptable procedure codes for Medicare Distant Site TeleHealth services.
- CMS has replaced CPT code 90862 with G0459.
- The 2013 HCPCS update will also replace several Current Procedural Terminology (CPT) codes related to psychotherapy services.

### Highlight #3 - New HCPCS Codes (cont'd)

HCPCS Code	Descriptor	
G0396	Alcohol and/or substance (other than tobacco) abuse structured assessment (for example, AUDIT, DAST) and brief intervention, 15 to 30 minutes .	
G0397	Alcohol and/or substance (other than tobacco) abuse structured assessment (for example, AUDIT, DAST) and intervention greater than 30 minutes .	
G0442	Annual alcohol misuse screening, 15 minutes .	
G0443	Brief face-to-face behavioral counseling for alcohol misuse, 15 minutes.	
G0444	Annual Depression Screening, 15 minutes.	
G0445	High-intensity behavioral counseling to prevent sexually transmitted infections, face-to- face, individual, includes: education, skills training, and guidance on how to change sexual behavior, performed semi-annually, 30 minutes.	
G0446	Annual, face-to-face intensive behavioral therapy for cardiovascular disease, individual, 15 minutes.	
G0447	Face-to-face behavioral counseling for obesity, 15 minutes.	
G0459	Inpatient TeleHealth Pharmacologic Management, including prescription.

### Highlight #6 - CEM Edit Update

- On 11/15/2013 the CEM edit X223.150.2300.DTP03.030 was implemented in the 4th Quarter EDFES CEM release.
- This edit will reject encounters with TOB 33X and DOS equal to or greater than 10/01/2013.
- MAO and other entities who received CEM edit X223.150.2300.DTP03.030 rejects on encounters submitted with TOB 33X with DOS prior to 10/01/2013 may resubmit those encounters.

### Tips for Transitioning to 2014

Do you have new staff or submission scenarios?

CMS encourages MAOs and other entities to utilize the Tier II testing environment when they have a staff member new to encounter data submission or when the organization has new submission scenarios that they wish to test prior to submitting the encounters to production.

### Tips for Transitioning to 2014 (cont'd)

# What are the submission deadlines for 2014?

It is important that MAOs and other entities adhere to CMS guidelines for timely submission of encounter data.

Submission Type	Timely Filing Deadline
Full Encounters	<ul> <li>13 months from the Date of Service (DOS)</li> <li>Institutional – "Through" DOS</li> <li>Professional – Service Line DOS</li> </ul>
Adjustment Encounter	30 days after the adjudication date if the adjustment is received after the 13 <sup>th</sup> month
Chart Review Encounters	Within 25 months of the data collection period

### Tips for Transitioning to 2014 (cont'd)



MAOs and other entities that have achieved end-toend certification in 2012 or 2013 are not required to recertify for encounter data submission in 2014.

## Tips for Transitioning to 2014 (cont'd)

What should I do if my contract is terminating in 2014?

- If a parent organization terminates all contracts with CMS effective 2014, the parent organization is not required to submit 2013 DOS.
- If a parent organization terminates one or more contracts with CMS, and still has active contracts, that parent organization must submit all 2013 DOS for the terminated contracts.

### Question #3 – MAO-002 Edit 22405

 What is the error description and edit logic for Error Code 22405 generated on MAO-002 Encounter Data Processing Status Reports?

### Answer #3 – MAO-002 Edit 22405

• The EDPS implemented Error Code 22405, "Occurrence Code 55 and DOD Required" to validate the presence of Occurrence Code 55 and date of death when a patient discharge status code of 20, 40, 41, or 42 is populated on an encounter.




**Informational -** Without an Occurrence Code 55 and a date of death from date of service 10/01/12-12/31/12

**Reject** - Without an Occurrence Code 55 and a date of death from date of service 01/01/13—current DOS

# Question #4 – Submitting More Than 12 Diagnosis Codes

- How can MAOs and other entities submit additional diagnosis codes to the EDS if the claims received from the provider contain more than 12 diagnosis codes for Professional encounters and more than 25 diagnosis codes for Institutional encounters?
  - For example, if an encounter has 15 diagnoses codes, should MAO and other entities split the encounter, the first encounter containing 12 codes and the second encounter containing 3 codes?
