#### Introduction

The purpose of this session is to provide Medicare Advantage Organizations (MAOs) and other entities with information on policy and operational guidance on testing and submitting production data to the Encounter Data System (EDS).





#### **MAOs and Other Entities**

- CMS requires the following types of organizations to submit encounter data:
  - Medicare Advantage (MA) Plans
  - Medicare Advantage-Prescription Drug (MA-PD) Plans
  - Health Maintenance Organizations (HMOs)
  - Special Needs Plans (SNPs)
  - Local Preferred Provider Organizations (PPOs)
  - Regional PPOs
  - Employer Group Health Plans
  - Programs of All-Inclusive Care for the Elderly (PACE) Plans
  - Cost Plans (1876 Cost HMOs/CMPs and 1833 HCPPs)
  - Medical Savings Account (MSA)
  - Private Fee-for-Service Plans (PFFS)
  - Religious Fraternal Benefit Plans (RFBs)
  - Provider Sponsored Organizations (PSO)

#### System Volume/Stress Testing – Edits Analysis

• The EDPS performed system volume/stress testing on four (4) professional files (197,635 encounters).

- Total Processing Errors 19,145
  - Reject Errors 14,420 (75%)

## System Volume/Stress Testing – Edits Analysis (cont'd.)

- The most commonly generated error code was 32005 "Payer ID not DME for DMEMAC Jurisdiction".
  - 26% of the total error codes generated
- The second most commonly generated error code was 98325 "Exact Duplicate of a Service Line within this Claim or a Previously Priced Claim".

25% of total error codes generated

• There was only a 2% difference in the encounter record rejection rate between MAO-002 reports for volume/stress testing and production.

#### **EDS File Size Limitations**

- Due to EDS limitations, the combination of all ST-SE transaction sets per file must not exceed certain thresholds.
- Effective the week of October 8, 2012, the EDS will implement front-end edits that will reject and return to the submitter all file submissions containing more than 5,000 encounters per transaction set (ST-SE) or more than 85,000 encounters per file.

#### **Production Data Catch-Up Plan**

- CMS has initiated a "catch-up" plan for the submission of production data for 2012 DOS beginning January 1, 2012 and forward.
- "Catch-up" production data should include all Professional, Institutional, and DME encounters.
- End-to-end certified MAOs and other entities should submit production data in monthly increments, beginning with the earliest dates of service, regardless of the number of contract enrollees.
  - January 2012, February 2012, March 2012, etc.

#### **Production Data Catch-Up Plan**

- MAOs and other entities should submit full encounters within the designated timely filing period.
- The timely filing periods have not been revised or extended for production data catch-up encounters.

SUBMISSION TYPE	TIMELY FILING DEADLINE
Full Encounter	<ul> <li>13 months from the DOS</li> <li>Institutional – "through" DOS</li> <li>Professional – Service Line DOS</li> </ul>
Correct/Replace or Void/Delete Encounter	13 months from the DOS not to exceed 30 days after the adjudication date of the adjusted claim
Chart Review Encounter	Within 25 months of the data collection period

## **Termination of Plans**

Termination – 2012	Termination – 2013 and Beyond
<ul> <li>If a parent organization terminates all contracts with CMS effective 2013, the organization is not required to submit encounters with 2012 DOS.</li> </ul>	<ul> <li>If a parent organization terminates all contracts with CMS effective 2014 and beyond, the organization must submit all encounters with DOS for the last active year.</li> </ul>
<ul> <li>If a parent organization terminates one or more contracts with CMS, but has other contracts with CMS, the organization must submit encounters with 2012 DOS for all contracts.</li> </ul>	<ul> <li>All encounters must be reported for any active period no matter when the encounter is adjudicated or when the plan is terminated.</li> </ul>

## **Incident Tracking Tool**

• As of October 1, 2012, 357 incidents have been received.

# of Resolved Incidents	320
# of Pending Incidents	37
Related to Known Issues	17
Potential Known Issues (under review)	4
Under further investigation	16

- Since April 2012, the volume of incidents has decreased from an average of 13 per day to three (3) per day.
  - Approximately 87% decrease rate

#### EDPS Edits – Prevention and Resolution

- The EDS team will analyze the EDPS edits in order to provide prevention and resolution strategies for the industry.
- CMS will communicate prevention and resolution strategies through User Group sessions, EDPS bulletins, and EDS Companion Guides:
  - Phase 1 will include the most frequently occurring edits generated.
  - Phase 2 will include the common edits received in all subsystems (Professional, Institutional, and DME).
  - Phase 3 will include all remaining edits.
    - Phase 3 will be ongoing.

#### **2011 DOS Solution Status**

- CMS is investigating the effective date for submission of 2011 DOS. Once the date is determined:
- MAOs and other entities may submit "*from*" dates of service (DOS) for 2011 and "*through*" DOS for 2012 for:
  - All Professional, Institutional, and DME encounters
    - Include Interim Bills **only** when the final bill "through" DOS is 2012.
    - Exclude Home Health, Hospice, SNF, and Swing Bed encounters until further guidance is provided.
- MAOs and other entities must **not** submit encounters with "from" <u>and</u> "through" 2011 DOS.
  - EDPS will only process 2012 "through" DOS encounter lines.
  - If 2011 "through" DOS lines are submitted, a line level rejection will be reflected on the MAO-002 report.
