



Encounter Data Processing System General Updates

- Beneficiary member eligibility Edits **02240 Beneficiary Not Enrolled in Medicare Advantage Organization for Date of Service** and **02110 Beneficiary Health Insurance Carrier Number (HICN) Not on File** have been resolved. MAOs and other entities who have verified member data and receiving these eligibility edits in error may resubmit files at this time.
- The **5/31/2012 deadline for Professional end-to-end testing** is quickly approaching. If you are still experiencing issues with Tier 1 test files, please submit your incidents to the EDS Incident Report Tracking Tool online at www.csscooperations.com with as much detail as possible, excluding beneficiary HICNs or other PHI (Protected Health Information).
- MAOs and other entities that have passed end-to-end testing for Professional should begin submitting production files immediately. CMS is advising MAOs and other entities to submit files upon certification without further delay.
- MAOs and other entities should continue submitting Institutional test cases to meet the **end-to-end Testing deadline on June 30, 2012**.
- To ensure MAOs and other entities are up-to-date on changes to EDS, the EDPS Bulletin will provide information on the submission of testing and production files on weeks that there is no User Group meeting.

MAO-002 Reports

- Currently, the following edits remain under further investigation and analysis. CMS is encouraging MAOs to provide detailed incident reports on the edits if the errors are returned on an MAO-002 Report.
 - 98325 Claim is an Exact Duplicate of a Previously Priced Claim
 - 03102 Provider Type or Specialty Not Allowed to Bill Procedure (This edit is currently an 'Informational' edit)

End-To-End Testing

- 20510 Revenue Code 540 Requires Specific HCPCS Codes
- 98325 Claim is an Exact Duplicate of a Previously Priced Claim
- 20505 Accurate Ambulance HCPCS and Revenue Code Required
- 03015 DOS Spans Procedure Code Effective/End Date
