# Introduction

The purpose of this session is to provide Medicare Advantage Organizations (MAOs) and other entities with information on policy and operational guidance on testing and submitting production data to the Encounter Data System (EDS).

# End-to-End Test Plan

# End-to-End Test Plan

- In response to industry feedback, CMS will provide MAOs and other entities the opportunity to submit additional test data.
- CMS has expanded the scope of professional end-to-end testing to include this additional level of plan testing.
- We have posted the End-to-End Test Plan at [www.csscooperations.com](http://www.csscooperations.com)
- The additional level of plan testing will be labeled Tier 2 – Plan Testing in the new Test Plan.
- Plan testing is intended to allow MAOs and other entities the opportunity to refine their end-to-end processes based on the submission of a more inclusive sampling of plan specific business cases.
- Tier 1 Testing (Test Case Scenarios) will continue as planned, but the timeline will be revised.

# End-to-End Test Plan

- We have released a document, Encounter Data System End-to-End Test Plan, via email and at [www.cssoperations.com](http://www.cssoperations.com) for MAOs and other entities to use as a guide in this process. The document describes the End-to-End Test Plan and is outlined here:
  - Overview
  - Tier 1: Test Cases for Certification
    - Plan contains description of the test case scenarios
    - The test cases **must** be used in conjunction with the 837-P Test Case Specifications and 837-P Business Case Scenarios located in the Professional Companion Guide.
    - **Required for Certification**
  - Tier 2: Plan Testing
    - Plan contains requirements for plan testing
    - Not required for certification
  - Certification Requirements
  - Timeline

# Tier 1– Review

## Tier 1 – Test Cases - No Change

- MAOs and other entities must submit identified test cases to ensure the submitters' systems are properly configured to map to the EDS' unique requirements.
- MAOs and other entities must achieve a 95% acceptance rate on total required test cases in order to be certified to submit production data.

# Tier 1- Review

CMS requires that the test cases are submitted in two (2) separate files.

File 1

Includes all unlinked test cases  
(19 test cases – 38 encounters)

*All encounters on File 1 must be accepted, as indicated on the MAO-002 report, before submitting File 2*

File 2

Includes all linked test cases  
(4 test cases – 8 encounters)

# End-to-End Testing – Tier 2

## Tier 2 – Plan Testing

- MAOs and other entities will have the opportunity to test additional samplings of data
  - Not a requirement for certification
  - MAO-002 reports will be distributed
    - CMS highly recommends that MAOs and other entities correct rejected encounters and resubmit
  - March 15, 2012 – April 30, 2012
    - Encounters submitted during this period will be removed after the testing period.
  - Up to 2,000 encounters per contract ID
  - Only 837-P encounters will be accepted

# End-to-End Testing – Tier 2

- Encounters must comply with TR3, CMS CEM Edits Spreadsheet, and Encounter Data Companion Guide.
- Encounters must include 2012 DOS only.
- Files must be identified using the Authorization Information Qualifier data element “Additional Data Identification” in the ISA segment (ISA01=03).

# End-to-End Testing – Tier 2

- Files must be identified using the Authorization Information data element to identify the “Tier 2 indicator” in the ISA segment (ISA02=8888888888).
- Files must be identified as “Test” in the ISA segment (ISA15=T).

All data will be deleted after April 30, 2012

# End-to-End Testing / Certification Timeline

We have also updated the end-to-end testing timeline in order to accommodate the additional plan testing.

\*MAOs and other entities must make an initial submission to the EDPS by this date.

# End-to-End Test Plan

- CMS will continue to send certification notices for successful completion of Tier 1 end-to-end testing.
- Production files will not be accepted until May 1, 2012.

# Minimum Data Elements

# Minimum Data Elements

- On March 1, we sent minimum data elements out to the industry for comment. We appreciated the comments that we received. The final minimum data elements have been posted at [www.csscooperations.com](http://www.csscooperations.com).
- Encounters must contain these elements in order to pass Encounter Data System (EDS) translator and CEM level edits. The minimum data elements are required to properly process and price encounters.
- Approximately 2/3 of the total minimum data elements are specific to the electronic submission of the file.
  - Operational guidance is provided in the TR3, CEM edits spreadsheets, and EDS Companion Guide.

# Minimum Data Elements

- MAOs and other entities may use these data elements for the submission of paper claims, member reimbursement claims, claims from foreign providers, etc.

An asterisk (\*) indicates the field is situational. If the situation occurs, this field is required. The tool does not include all situational fields.

# Ambulance Services

- CMS has developed criteria for the submission of ambulance service data for encounter data.
- Based on industry feedback, ambulance pick-up and drop-off locations are often missing from claims received from providers.

# Ambulance Services

1. Provide the zip code for ambulance pick-up and drop-off locations if available.
2. Provide the zip code for the Rendering Provider if the zip code for ambulance pick-up and drop-off is unavailable.
3. Provide the zip code for the Billing Provider if the Rendering Provider is the same as the Billing Provider and the ambulance pick-up and drop-off is unavailable.
4. Populate a value of 'AM' in PWK01, and a value of "AA" in PWK02 to indicate ambulance pick-up and drop-off is not available and the Rendering or Billing Provider information is populated.

# Professional Edits

- CMS distributed a Proposed Edits Comments tool
- MAOs and other entities responded with comments and updates were made to the original proposed EDPPPS edits

# CMS Updates

# §1876 Cost HMOs/CMPs and §1833 HCPPs

- On Monday, 3/12, cost plans should have received an update/clarification regarding their encounter data submission requirements.
- CMS will only require submission of encounter data for Medicare covered items/services which plans claim on their CMS Cost Reports.
- Testing of institutional encounter data is not required for “billing option 1” Cost Plans or HCPPs.

# PACE

- During the initial phase of Encounter Data planning, CMS conducted a series of various Work Groups; one of which focused on Program of All-Inclusive Care for the Elderly (PACE) requirements
- As Encounter Data guidance progresses in the implementation phase, CMS is revisiting the unique requirements for PACE Organizations
- The initial PACE Work Group is scheduled for Wednesday, March 21, 2012
- Registration is required

# Front-End Certification

- The deadline to meet front-end certification was January 3, 2012.
  - MAOs and other entities who are not front-end certified should do so immediately.
  - Compliance Alerts were distributed on March 1, 2012.
  - Noncompliance letters will be issued to MAOs and other entities not certified by March 14, 2012.
