Introduction

The purpose of this session is to provide Medicare Advantage Organizations (MAOs) and other entities with information on policy and operational guidance on testing and submitting production data to the Encounter Data System (EDS).





MAOs and Other Entities

- CMS requires the following types of organizations to submit encounter data:
 - Medicare Advantage (MA) Plans
 - Medicare Advantage-Prescription Drug (MA-PD) Plans
 - Health Maintenance Organizations (HMOs)
 - Special Needs Plans (SNPs)
 - Local Preferred Provider Organizations (PPOs)
 - Regional PPOs
 - Employer Group Health Plans
 - Programs of All-Inclusive Care for the Elderly (PACE) Plans
 - Cost Plans (1876 Cost HMOs/CMPs and 1833 HCPPs)
 - Medical Savings Account (MSA)
 - Private Fee-for-Service (PFFS) Plans
 - Religious Fraternal Benefit Plans (RFBs)
 - Provider Sponsored Organizations (PSOs)

- All incidents previously submitted to the EDS Incident Tracking Tool that are currently pending resolution will be addressed and resolved.

True Coordination of Benefits





True COB

- Per 5010 requirements and the TR3
 Implementation Guide, population of the primary payer adjudication information is situational; however, these fields are required for submission of true COB encounters.
 - Loops 2320, 2330, and 2430
- When the primary payer adjudication information is not captured in the secondary payer's system:
 - MAOs and other entities should coordinate with the primary payer to obtain the required adjudication information.

Encounter Data and Medicaid Encounter Data

- Medicaid encounter data is commonly collected and reported through the Medicaid Encounter Data System (MEDS).
 - MAOs and other entities should not submit any services to the EDS that are covered and paid by Medicaid.
- Medicaid-covered services should be extracted from encounter data submission by populating Loop 2300 NTE01 = 'ADD', NTE02 = 'MEDICAID CLAIM CHANGE DUE TO MEDICAID SERVICE LINE EXTRACTION'.





Encounter Data and Medicaid Encounter Data (cont'd.)

- Select MAOs and other entities are participating in a CMS Financial Alignment Initiative for dual Medicare-Medicaid Plans (Med-Med) coordination and integration.
- Once the Initiative is tested and validated, CMS
 will analyze the data to review the Med-Med
 submission requirements and determine any
 potential impact these submissions may have on
 Medicaid encounter data processing and pricing.

- MAOs and other entities may review the "Marketing in Medicare-Medicaid Plan Demonstration Areas" Memo for information regarding the details of the Financial Alignment Demonstration.

2011 DOS Updates





2011 DOS Updates

- Effective November 26, 2012, MAOs and other entities may submit "from" dates of service (DOS) for 2011 and "through" DOS for 2012 for all Professional, Institutional, and DME encounters.
- CMS will remove the requirement for 2011 DOS proxy data:
 - NTE02 = 'DOS CLAIM CHANGE DUE TO 2011 DOS DURING EDS IMPLEMENTATION PERIOD'.
- MAOs and other entities are not required to resubmit encounters containing 2011 DOS that were submitted prior to November 26, 2012.





2011 DOS Updates (cont'd.)

- If encounters are submitted with "from" <u>and</u>
 "through" 2011 DOS, a line level <u>rejection</u> edit
 will be generated:
 - Edit 00012 "Date of Service is Less Than 01-01-12"
- If encounters are submitted with 2011 "from"
 DOS and 2012 "through" DOS, a line level
 <u>informational</u> edit will be generated:
 - Edit 00013 "Crossover Encounter From 2011"





DME HCPCS Fee Schedule





DME HCPCS Fee Schedule

- CMS developed a job aid to assist MAOs and other entities with submission of DME HCPCS codes to accurately identify DME Supplier vs. DME Incident to services.
- The job aid requires further evaluation to provide effective guidance for DME encounter data submission.
- CMS will provide further information once decisions are finalized.
 - Updates will be communicated during a future User
 Group session and will be published in a future release of the CMS EDS 837-P DME Companion Guide.



SNF/HH Submission Update





SNF/HH Submission

- Health Insurance Prospective Payment System (HIPPS) codes are case-mix groups, representing specific patient characteristics, used to determine payment.
- HIPPS codes are reported on claims received from providers and submitted to MAOs and other entities.
- Effective July 2013, MAOs and other entities are required to submit these HIPPS codes for all SNF/HH encounter submissions.
