A Medicare Advantage Organization (MAO) initially submits an encounter data record prior to the PY 2019 final risk adjustment data submission deadline with diagnoses DxA and DxB. Shortly after, the MAO submits a replacement record that includes both DxA and DxB but has a Type

of Bill Code that is not allowed. After the PY 2019 final risk adjustment data submission deadline but before the overpayment deadline the MAO submits a new replacement record that changes the Type of Bill Code back to the original.

The encounter includes the Type of Bill (TOB) 13X, and diagnoses DxA and DxB.  The MAO-002 will report this record as preliminarily allowed ("PA") and the MAO-004 will report this record as allowed ("A") because it is associated with an allowed TOB. The MAO-004 will indicate that DxA and DxB are in "Add" status ("A").  Since these diagnoses were added prior to the PY 2019 final risk adjustment data submission deadline, and are risk adjustment eligible (see the December 22, 2015 HPMS memo, <i>Final Encounter Data Diagnosis Filtering Logic</i> ), they will be included in the PY 2019 final risk adjustment reconciliation payment.

The MAO-002 will report this record as preliminarily disallowed ("PD") with the reason code indicating that the TOB is not allowable ("PT") and the MAO-004 will report this record as disallowed ("D") with the reason code indicating that the TOB was not allowable ("T"). The MAO-004 will still indicate that DxA and DxB are in "Add" status ("A"). Although the replacement record indicated both diagnoses are in "Add" status, they will not be included in the PY 2019 final risk adjustment reconciliation payment because they were disallowed due to the TOB on the replacement record (see the December 22, 2015 HPMS memo, Final Encounter Data Diagnosis Filtering Logic).

The MAO-004 will indicate that DxA and DxB are in "Add" status ("A").  Despite the updated TOB code on this replacement being an acceptable code per the December 22, 2015 HPMS memo, Final Encounter Data Diagnosis Filtering Logic, diagnoses DxA and DxB will not be eligible for payment because they were removed due to an ineligible TOB in the prior record and then re-added through a replacement record after the PY 2019 final risk adjustment data submission deadline (see 42 CFR 422.310g(2)(ii)- After the final risk adjustment data submission deadline, which is a date announced by CMS that is no earlier than January 31 of the year following the payment year, an MA organization can submit data to correct overpayments but cannot submit diagnoses for additional payment).
